

## Fees

Rule 408 of the South Carolina Appellate Court Rules (SCACR) provides that the Commission, subject to the continuing jurisdiction of the Supreme Court, shall have general jurisdiction over all matters pertaining to mandatory continuing legal education (CLE) and specialization in the practice of law and shall make a list of all fees available to the public. Fees are adopted by the Commission and may be modified as specified by rule or otherwise authorized by law.
